SEGMENT ONE INSTRUCTION:

Auto XL Driving School will provide a minimum of 24 hours of classroom instruction, 6 hours of behind-the-wheel (BTW) instruction, and 4 hours of observation time. Classroom instruction must be a minimum of 3 weeks in length. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction. BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed. Auto XL Driving School will conduct the behind-the-wheel instruction in a dual controlled automobile, fully insured, covering each student enrolled in the program.

SEGMENT FEE: \$ 285.00 For Segment One Only (price reflects \$50.00 off coupon)

Prices subject to change without notice. Contract price is honored with minimum \$100.00 payment. Full payment is due the first day of class. Refunds will only be given on or before 2nd day of class. Any student that is expelled for inappropriate behavior (as described in the Auto XL procedures) will not receive a refund. Payment can be made by cash, check or money order. There is a \$30.00 fee for any returned check due to non-payment. Additional drive time may be purchased at \$40.00 per hour after the student has completed Segment 1.

If a certificate is lost, a replacement may be obtained for a fee of \$10.00 cash. If the student loses, damages or destroys the class manual, or study guide there will be a \$30.00 cash replacement fee. Students will not receive a certificate of completion unless all fees that are owed are paid.

The student must be 14 years 8 months of age by the first scheduled day of class (verification by birth certificate is required) and not older than 18 years of age. Students must complete Segment 1 before their 18th birthday or they will not be allowed to complete Segment 1 and will not receive a refund. Students must attend all scheduled class time. Students must complete all homework assignments, quizzes and tests, **and pass the State Test by 70 %**. The student will be allowed 3 attempts to pass the state exam. If the student does not pass the state exam they will have to retake the classroom portion of Segment 1 and will have 3 more chances to pass the state exam. If the student misses a class day, this identical day must be made up in the next available class. If two or more classes are missed, the student must make up the missed days in the next available class before they will be able to take the state issued driver education test for segment 1. Students are not allowed by law to be in class more than 2 hours a day or behind the wheel more than 1 hour per day. There is no additional charge for missed classes. Students must complete all requirements for Segment 1 within 90 days or the student will be required to retake the classroom portion of Segment 1. There will be no additional charge if the student is required to retake the classroom portion of Segment 1.

Students who need to change or reschedule a confirmed drive time must do so with their class room instructor. If the drive time can be filled the student not be charged a no show fee. If the drive time can not be filled, the student will be charged a \$30.00 cash no show fee. If the student misses a drive time or is more than 5 minutes late for their drive time for any reason or do not have appropriate foot wear (as described in the Auto XL procedures), they are considered a no show and will not be able to drive that day and will be charged a \$30.00 cash rescheduling fee. The students drive time will not be rescheduled until the no show fee has been paid. Students that wear corrective lenses during the eye exam must wear their corrective lenses for behind-the-wheel lessons. If the student does not have their corrective lenses they will not be able to drive that day and will be charged a \$30.00 cash rescheduling fee. The students drive time will not be rescheduled until the no show fee has been paid.

As part of the consideration in the payment and providing of services here to, all enrolled students, their parents and or the undersigned legal guardians agree to hold harmless and indemnify AUTO XL DRIVING SCHOOL, its employees and agents from any and all actions, conduct, errors and omissions caused by the enrolled student during and or after the course of said students involvement, study and driving with AUTO XL DRIVING SCHOOL. AUTO XL DRIVING SCHOOL reserves the right to deny admittance to the school or expel any student from the school for any reason.
