SEGMENT TWO INSTRUCTION:

Each student will receive a minimum of 6 hours of classroom instruction on defensive driving by a certified instructor as required by Michigan Department of State and Michigan Department of Education. Classroom instruction shall not exceed 2 hours per day.

SEGMENT FEE: \$50.00 For Segment Two

REFUND POLICY: The fee for Segment Two must be paid in full by the first day of class and is non-refundable after the first day of class. Payment can be made by cash, check or money order.

TERMS: The student must attend all class time consecutively. If a day is missed or the student is more than 10 minutes late for class the student must retake Segment 2. There is no additional charge to retake the class. Students must complete Segment 2 before their 18th birthday or they will not be allowed to complete Segment 2 and will not receive a refund. Students must attend all scheduled class time. The student must pass the Segment 2 state exam by 70% in order to complete the course and receive a certificate of completion.. The student will be allowed 3 attempts to pass the state exam. If the student does not pass the state exam they will have to retake the classroom portion of Segment 2 and will have 3 more chances to pass the state exam. There is a \$30.00 fee for any returned check due to non-payment. If a certificate is lost, a replacement may be obtained for a fee of \$10.00. Students will not receive a certificate unless all fees owing are paid. All fees must be paid by cash only.

For a student to participate in Segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent, guardian or parent designee on a level 1 license, which has been held for not less than 3 continuous months.

STUDENTS ARE REQUIRED TO PRESENT A LOG DOCUMENTING THEIR SUPERVISED PRACTICE DRIVING PRIOR TO BEGINNING A SEGMENT 2 CLASS. THE STUDENT MUST ALSO SHOW THEIR LEVEL 1 LICENSE, TO THE INSTRUCTOR ON THE FIRST DAY OF CLASS BEFORE INSTRUCTION BEGINS. THE "ISSUE" DATE OF THE LEVEL 1 LICENSE MUST BE LEGIBLE. IF THEY DO NOT HAVE THEIR LEVEL 1 LICENSE AND DRIVING LOG, THEY WILL NOT BE ABLE TO ATTEND THE CLASS.

As part of the consideration in the payment and providing of services here to, all enrolled students, their parents and or the undersigned legal guardians agree to hold harmless and indemnify AUTO XL Driving School, its employees and agents from any and all actions, conduct, errors and omissions caused by the enrolled student during and or after the course of said students involvement, study and driving with AUTO XL DRIVING SCHOOL.

AUTO XL DRIVING SCHOOL reserves the right to deny admittance to the school or expel any student from the school for any reason.
